## Semen Contract for 2025 Breeding Year

1) The **STALLION FEE** is **\$1800.00 Breeding Fee** is due **BEFORE ANY SEMEN WILL BE SHIPPED**. There is no booking fee. A copy, both sides, of your mare's registration papers must accompany this completed & signed contract. The owner recorded on the registration certificate will be the owner recorded on the Stallion Breeding Report. **COPY OF MARE'S PAPERS & THE FIRST 2 PAGES OF THE SIGNED CONTRACT MUST BE MAILED OR EMAILED TO US AT THE ADDRESS LISTED AT THE TOP OF THIS CONTRACT.** THE BREEDING FEE MAY BE SENT BY ANY OF THE PAYMENT OPTIONS LISTED BELOW.

3) **LOCAL BREEDING SERVICE IN Piedmont, SD:** Mare Owner/Lessee interested in having mare bred in Rapid City area, we suggest Jessica Harvey, DMV at Red Valley Genetics, 13171 High Plains Place, Piedmont, SD 57769 605-787-4808 or 605-787-8315.

4) This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is stillborn, or the mare absorbs/aborts a predetermined pregnancy there are return privileges, only if the Stallion Owner/Manager is notified within ten (10) days and receives a veterinarian statement confirming this. **A "Live Foal Guarantee" will apply only to those mares that are certified in foal by a licensed, attending veterinarian. Confirmation of such pregnancy in the form of documented ultrasound picture or letter from the attending veterinarian must be received by OCTOBER 1 of the breeding year.**

5) If the mare does not conceive, or deliver a live foal, during the contracted season the mare will have rebreeding privileges the following year only. The Stallion Owner/Manager may approve a substitute mare to use the rebreeding privilege. A substitute mare, accepted by the Stallion Owner/Manager, may be used ONLY if the original mare is deceased or deemed unfit for breeding by an accredited veterinarian. If the mare owner fails to rebreed the following year after the original contracted season, then all fees become forfeited. The right to rebreed is cancelled and the stallion owner is released from all further obligations of this contract unless otherwise agreed in writing & signed by both parties. \_\_\_\_\_ (Mare Owner/Agent to Initial Here)

6) A Breeder's Certificate will be issued for the foal conceived because of the breeding. The Breeder's Certificate will be issued only after all expenses have been paid in full and after the foal is born and has been reported to the Stallion Owner/Manager. **After the mare is confirmed in foal, your vet or you MUST report back to stallion owner via mail or email with mare's name and breeding date(s).**

7) Roger Joseph and Joseph Quarter Horses nor any of its members or employees shall be liable for damages because of damage to the semen or because of the mare failing to settle. Roger Joseph's sole liability under this contract is in the event the stallion should die or become unfit for breeding purposes this contract shall convert to frozen semen only if available. **ONLY THE CURRENT BREEDING FEES ASSOCIATED WITH THIS CONTRACT WILL BE REFUNDED** \_\_\_\_\_ (Mare Owner/Agent to Initial Here)

8) When signed by both parties this document will become a legally enforceable contract, binding upon both parties. The parties acknowledge that this agreement shall be entirely governed by, construed and enforced under the laws of the State of South Dakota. If there is any dispute, all disputes of every kind between the parties to this agreement shall only be submitted to arbitration and any award made by the arbitrators shall be considered final and binding. **This contract is non-transferable and cannot be sold.**

## Pre/post-breeding check list

- A. Find a good reproduction vet.
- B. Worm and vaccinate mare to be bred **30 days prior to breeding** with WNV, rabies and 5-way.
- C. Before ordering semen, we highly recommend you have your mare cultured to make sure she has no infections, and a cytology is also highly recommended.
- D. Shipped Semen Fees must be paid before semen is sent out.
- E. Have mare checked in foal at **14 to 17 days** (to make sure she is pregnant and has no twins, after 17 days it's much harder to pinch off a twin and higher risk of losing them both) and checked again at **25 to 30 days for a foal heartbeat. (Mare owner must report back within 30 days of mare being bred, or live foal guarantee will be null and void)**
- F. Have a caslick performed, if needed, when mare is safe in foal to prevent Placentitis.
- G. Vaccinate pregnant mares with Pneumoabort K shot at **5, 7, and 9 months** of pregnancy to prevent abortion
- H. Worm mare, give Rotavirus shot & all annual shots and have caslick removed **30 days prior to foaling.**
- I. Worm mare **within 24 hours of foaling** to help control foal heat scours in the foal
- J. Drench foals' umbilical cord 2-3 times a day in a diluted chlorhexidine mix until dried up. If a foal is having difficulty eating or sluggish movements, contact your vet right away for possible test foal IgG within 12 hours of birth.

## **RED VALLEY GENETICS, LLC**

### **To have COOLED EQUINE semen shipped:**

1. Collection days are Monday, Wednesday, and Friday.
2. Mare owner needs to contact Red Valley Genetics, LLC the day before or the day of by 10 am Mountain Time to order semen.
3. **ALL** semen orders need to be placed via phone at 605-787-4808.
4. The following list is REQUIRED when placing an order for semen:
  - a. Mare owner's information (address, phone number etc.)
  - b. Shipping information
  - c. Mare's name and registration number
  - d. Shipping date
  - e. Payment information
    - If clients choose to pay with a check, they will need to send it prior to ordering semen. Semen will not be shipped until payment is received.
5. Cooled semen Charges:
  - a. \$500.00 + tax for FedEx/UPS next day delivery. (Saturday delivery is additional)
  - b. \$425.00 + tax counter-to-counter delivery if available. Difficult to arrange successful flights in our area
  - c. \$250.00 + tax for any semen picked up.
  - d. Credit card fee if applicable at 3.5%

### **To AI mares at Red Valley Genetics, LLC: To stallions standing at Red Valley Genetics**

1. Collection days are Monday, Wednesday, and Friday.
2. Mares can be dropped off and picked up **Monday through Friday 8-4.**
3. Every mare will need a CURRENT health paper with Red Valley Genetics, LLC as the destination and a CURRENT negative COGGINS. We will need all that paperwork on arrival, or the mare will **NOT** be unloaded onto the facility.
4. We will need a copy of registration papers if available on the mare.
5. Charges:
  - a. \$350.00 per AI cycle fee, includes all palpations
  - b. \$200.00 one-time collection fee per mare.
  - c. \$20/day for dry mares and \$22/day for wet mares.
  - d. Any additional vet work or necessary medication is additional.

**Call at least one day in advance to schedule arrival times of your animals to assure availability.**

**The facility does have security gates that remain locked during the evening AND weekends. This security requires a person to be present in the office to open gates.**
